

**RESOLUTION APPROVING THE COMPENSATION AMOUNT FIXED BY THE
GORDONS CORNER FIRE COMMISSIONERS**

WHEREAS, on September 20, 2023, the Manalapan Township Board of Fire Commissioners District No. 1 adopted the following Resolution Establishing Commissioners Compensation for 2023:

Commissioner Spector offered the following Resolution and moved its adoption which was seconded by Commissioner LaRocca.

WHEREAS, the Manalapan Township Board of Fire Commissioners District No. 1 intends to fix the amount of compensation each Commissioner shall receive in 2024; and

WHEREAS, N.J.S.A 40A:14-88 provides that annually the Board shall adopt a Resolution establishing the level of compensation for the Commissioners and forward it to the Township Committee of the Township of Manalapan for review.

NOW THEREFORE BE IT RESOLVED by the Manalapan Township Board of Fire Commissioners District No. 1 that each of the five Commissioners shall receive \$8,130 as compensation for the calendar year 2024; and

BE IT FURTHER RESOLVED that a copy of this Resolution shall be forwarded to the Township Committee of the Township of Manalapan for its review and approval; and

BE IT FURTHER RESOLVED that a copy of this Resolution certified to be a true copy shall be retained in the permanent files of the Board; and

WHEREAS, the Township Committee of the Township of Manalapan has reviewed the aforesaid Resolution adopted by the Board of Fire Commissioners in accordance with N.J.S.A. 40A:14-88.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Manalapan, County of Monmouth and State of New Jersey, that the Township Committee of the Township of Manalapan hereby approve the 2024 annual compensation of the Board of Fire Commissioners of the Manalapan Township Board of Fire Commissioners District No. 1.
